

LEGAL ADVERTISEMENT REQUEST FOR PROPOSALS

NOTICE is hereby given that proposals are requested for Naming Rights for Stafford Township Arts Center (STAC), and Sponsorship Promoter Services for Stafford Township Arts Center (STAC) and will be received, publicly opened and immediately read thereafter by the Stafford Township School District Board of Education through Lourdes LaGuardia, School Business Administrator/Board Secretary, in the County of Ocean, State of New Jersey, on June 11, 2019, at 11:30am for Naming Rights for STAC; and 12:00N for Sponsorship Promoter Services for STAC prevailing time in the Stafford Room, Oxycocus Elementary School, 250 North Main Street, Manahawkin, NJ 08050.

The Request for Proposals will be available electronically on the district's website www.staffordschools.org beginning on Thursday, May 23, 2019. Proposals must be submitted in sealed packages. The sealed packages shall be delivered between the hours of 9:00 a.m. and 3:00 p.m., Monday through Friday, to the Office of the School Business Administrator, Oxycocus Elementary School, 250 North Main Street, Manahawkin, NJ 08050. The sealed packages shall bear the name and address of the proposer and shall be marked as "Naming Rights for STAC Proposal" and/or "Sponsorship Promoter Services Proposal". The original and three copies of each proposal should be submitted. All proposals MUST be submitted and time- stamped by the Office of the Business Administrator no later than the date and time designated for opening. The Stafford Township School District Board of Education will not be liable for any proposals lost in the mail or misdirected by any party.

All proposers are required to comply with the requirements of PL 1975, Chapter 127, Affirmative Action Against Discrimination (N.J.A.C. 17:27). Attention is called to the fact that successful proposers shall ensure that employees and applicants for employment are not discriminated against because of their age, race, color, creed, sex, national origin, ancestry, marital status or affectional or sexual orientation.
